## **Community Infrastructure Project 1:** Project name and location: Repair to War Memorial £1320 **Provision of Community Information boards £5137** Brief description of works undertaken: Project 1. In 1920 Hardwicke Parish Council erected a lychgate to Hardwicke Church. The entrance to the lychgate contained to two memorial plagues to record the lives of local men from Hardwicke who gave their lives during the two world wars. Over the years the inscriptions became faded and it was difficult to read the inscriptions. The Parish Council engaged the services of a local stonemason to clean the plaques and to re-inscribe the names. This was undertaken to coincide with Remembrance Sunday. Work Completed November 2021 **Project 2 Community Information Boards** Delivered in response to requests from local community groups to have access to facility to publish information. **Date Project Completed: Project 1 Completed November 2021 Project 2 Completed February 2022** Has the project been successful? How? Project 1 Very well received by residents and those who are related to those who died in the two world wars. The work followed extensive research undertaken by a local resident who accessed information from the County Record Office to provide the historic background/ Project 2 Was delivered in response to requests from residents for the provision of local information points at two new developments (and one further development which has a large community) in the Parish. The information points are used by community groups who have their own access to publish information.
