Is the project needed to directly help address the pressures created by new housing development being built in the area?

# Alternative sources of help and support for Local Neighbourhood Projects

## **CIL Neighbourhood Portion.**

This is a separate stream of CIL funding, collected from new housing development to support the delivery of smaller community projects. All monies collected into the CIL Neighbourhood Portion are automatically given to the relevant Town and Parish Council every 6 months, in April and October of each year. The recipient Town and Parish Council decide what are their local priority infrastructure projects, and we have seen this invested in a wide range of local facilities such as play areas, community halls, sports grounds and walking and cycling tracks. Monies cannot however be used to purchase land and should be spent within 5 years of receipt.

#### Project development & Funding advice.

SDC have an agreement with the Gloucestershire Rural Community Council (GRCC) for them to help community organisations in the Stroud District with a range of issues, including project and business planning to fundraising support and organisational development.

GRCC can help community groups to undertake successful community engagement and consultation, which is essential in building an evidence base for funders. They can then help with finding potential funders and acting as a critical friend with the application process.

In addition to the above, GRCC also run Voluntary and community Sector (VCS) network meetings for representatives of the voluntary sector groups in the stroud district. Members can meet peers, develop fundraising ideas and share best practice on governance and organisational issues.

#### Village Halls and Community Buildings.

In addition to the services stated above, GRCC also provide a specialist advice service for the committees of community halls. GRCC are experienced in understanding the nuances of operating multi-use community facilities and they also run a county-wide 'Community Buildings Network' that meets 5 times a year, where committee members can meet each other and share knowledge on problem solving and best practice.

#### **Sports & Recreation Facilities.**

SDC's <u>Leisure and Wellbeing Strategy</u> provides an important framework for delivering and facilitating leisure, health and wellbeing provision across the district for the next 20 years. SDC's <u>Playing Pitch Strategy</u> gives a robust audit and assessment evidence base of open space and sport and recreation areas, set within a Green Infrastructure network. It informs policy and development and aims to help protect and improve the accessibility and quality of the existing open space network and supports the provision of new open space.

SDC's <u>Open Space</u>, <u>Green Infrastructure</u>, <u>Sport and Recreation Study</u> looks at the current and projected needs for open space, green infrastructure, sport and recreation in Stroud District.

SDC's <u>Physical Activity Action Plan</u> provides opportunities for everyone to be more active and gain the many benefits that being active can bring, regardless of age or ability. The plan's core objectives are: 1) Active Start - to increase levels of participation by children and young people 2) Active Everyday - to provide opportunities for adults to build physical activity into everyday life 3) Stay Active - to encourage older adults to maintain and continue to lead active lives.

#### **Other Fundraising Opportunities**

**Community Wellbeing Grant** - SDC fund voluntary and community organisations through the. This grant is for a three year term and applicants must satisfy a number of criteria based on community wellbeing. The current grant term will end in April 2025. Information about the next tranche of Community Wellbeing funding will be available shortly before this date.

**Small Grants** - SDC is currently reviewing the process of fund raising for small grants of less than £1000. It is hoped the Council will find a way to match fund while generating external funding for smaller bids. Further information on this will follow in 2023.
